INVITED PLENARY AND SESSION SPEAKERS, PER THE PROGRAM



Dr. Dan Deckelbaum

Dr. Dan Deckelbaum is assistant professor at the Divisions of Trauma and General Surgery at the McGill University Health Centre (MUHC), associate member of the Department of Epidemiology, biostatistics and occupational health at McGill University, and honorary associate professor of the National University of Rwanda. He obtained his subspecialty training in trauma surgery and critical care at Jackson Memorial Hospital in Miami. During his fellowship, he also completed a Masters of Public Health at the University of Miami.

In addition to his passion for clinical practice, he has developed an avid interest in global surgical education and development, as well as disaster preparedness and response, establishing and codirecting the MUHC Centre for Global Surgery. His interest in global health is founded upon onsite clinical experience in government hospitals in East Africa as well as disaster response activities in Somalia, Kenya, Turks and Caicos, and Haiti. This clinical experience is the basis for ongoing capacity building programs in resource limited settings across the globe. This includes education programs in resource limited setting.

Dr. Tarek Razek



Dr. Tarek Razek is the trauma program director and the chief of the division of trauma surgery at the McGill University Health Center (MUHC) since 2004. He completed his postgraduate training in trauma surgery and critical care at the University of Pennsylvania. His interest in global

surgical issues began early in his career with participation in the medical educational programs of the Canadian Network for International Surgery (CNIS) in Tanzania and Ethiopia. He has continued to participate in and develop medical educational programs over the past ten years, especially the Trauma Team Training program.

He has been the Chair of the Board of the CNIS, which oversees hundreds of surgical, obstetric, and injury prevention programs predominantly in sub-Saharan Africa. Additionally, He has been active in the area of disaster response in the regional, national and international arenas acting as chair of the disaster committee for the Trauma Association of Canada and participating as part of the Canadian federal Disaster response teams deployed to support surgical services at the Vancouver Olympics of 2010. He consulted for the preparations of the Euro 2012 in the Ukraine.



Dr. Emilie Joos

Originally from Montreal, Dr. Joos completed her medical school at McGill University where she obtained her M.D.C.M degree. She then underwent general surgery residency at Laval University, in Quebec city, from 2007 to 2012. From 2012 to 2014 she completed a Trauma and Surgical Critical Care

fellowship at University of Southern California/Los Angeles County Hospital. She then joined the group of trauma surgeons at Vancouver General Hospital. She completed a Masters in Global Health Policy at the London School of Hygiene and Tropical Medicine in 2019. She has been working with Médecins Sans Frontières since 2015 and was deployed several times in Sub-Saharan Africa. In 2017 she completed her Emergency Response Unit training with the Canadian Red Cross and is now on the roster for deployment. Dr. Joos is the Associate Director of the UBC Branch for International Surgical Care and the Trauma and Acute Care Surgery Fellowship program director.

Dr. Joos is a fellow of the Royal College of Surgeons of Canada in General Surgery and obtained her Critical Care accreditation from the Royal College in 2014. She is a Fellow of the American Board of Surgery.

Dr. Joos is a course director for the Advanced Surgical Skills for Exposure in Trauma, the Definitive Surgical Trauma Care and the Advanced Trauma Life Support courses. She is the provincial chair for ATLS in British Columbia.



Dr. Nicole Jedrzejko

Nicole Jedrzejko is a fourth-year general surgery resident based in Vancouver, BC at the University of British Columbia. Originally from Orangeville, Ontario, she is the first-generation daughter of Somali and Polish immigrants and completed her BHSc and MD degrees at McMaster University. She aims to deliver high-quality surgical care in community

settings to equalize socioeconomic, cultural, and geographic disparities in health outcomes with a focus on cancer care both nationally and internationally.



Dr. Phyllis Kisa

Phyllis Kisa, a Ugandan Pediatric surgeon and Pediatric urologist who completed medical school at Makerere University, Kampala, Uganda. Then she worked as an intern doctor and as a medical officer (general doctor) in the surgical department at St. Mary's Hospital Lacor, Uganda.

Following this, Dr. Kisa got an MMED in General surgery from Makerere University and Fellowship in General Surgery of the College of Surgeons of East, Central and Southern Africa. Soon after, she started a pediatric surgical fellowship training with the College of Surgeon of East Central and Southern Africa (COSECSA). She had a hybrid training with part in Uganda and part spent at the Children's Hospital in general surgery and pediatric urology in Vancouver, BC, Canada, where she completed a formal clinical fellowship in pediatric urology. She became the first clinical fellow returned to Uganda to continue working as a pediatric surgeon and the first fellowship-trained pediatric urologist.



Dr. Melanie Morris

Dr. Melanie Morris is an indigenous pediatric surgeon and urologist at the Children's Hospital in Winnipeg. Melanie has recently been appointed the Inaugural Lead on Indigenous Health at the Children's Hospital in Winnipeg. Dr. Morris founded with the Department of Surgery the Winnipeg Global Surgery Office and currently serves as the medical director. Melanie has supported teaching and training in the area of Pediatric Surgery in Kenya and Uganda and

remains an active board member of The College of Surgeons of East, Central and Southern Africa. Melanie is an instructor for the University of British Columbia, College of Medicine's Masters in Global Surgery program on Indigenous Health.

Dr. Morris has been working with Ongomiizwin to create outreach clinics with pediatric surgery in Nunavut. Her most recent interest is in developing culturally safe spaces for Indigenous children receiving care at the Winnipeg's Children's Hospital For this work, Dr. Morris is engaging Indigenous parents, children and Elders in priority-setting, designing and evaluating all phases of the transformation of the Children's Hospital.



Dr. Susan Moffatt -Bruce

Susan D. Moffatt-Bruce, MD, PhD, MBA, FACS, FRCSC, became the new CEO of the Royal College on January 6, 2020. She joins the Royal College from the Ohio State University (OSU) Wexner Medical Center University Hospital where she served as executive director for two years. Prior to that role, she was the OSU Wexner Medical Center's inaugural chief quality and patient safety officer. She is a professor of surgery and biomedical informatics at OSU.

After completing her undergraduate degree at McGill University, she attended medical school at Dalhousie University. During her General Surgery residency at Dalhousie University, Dr. Moffatt-Bruce undertook a PhD in Transplant Immunology at the University of Cambridge, England. She went on to complete her fellowship in Cardiothoracic Surgery at Stanford University, California. She has also trained at Intermountain Healthcare, the Institute for Healthcare Improvement and Harvard School of Public Health.

A highly-regarded thoracic surgeon and funded research scientist, Dr. Moffatt-Bruce holds leadership positions in the American Association of Thoracic Surgery, the Society of Thoracic Surgeons, the National Quality Forum and America's Essential Hospital.



Dr. Dr. Stephanie Sinclair

Anishinaabe, Mother of two children ages 11 and 16, Masters in Clinical Psychology, completing PhD in Native Studies at University of Manitoba, PI for Supporting the Trajectory of Our Spirit (iHELTI), and working as a research coordinator for FNHSSM Indigenous Doula Research Project



Dr. Donna May Kimmaliardjuk

Donna May Kimmaliardjuk (Inuk) who is the first Inuk heart surgeon in what is known as Canada. Dr. Kimmaliardjuk is currently completing her residency training in cardiac surgery at the University of Ottawa Heart Institute. In 2016, Dr. Kimmaliardjuk joined the National Aboriginal Council on HIV/AIDS as the Inuit representative, where she provides the council with a unique and

crucial perspective combining her knowledge of medicine and Inuit culture.

Donna's mother is Inuk and grew up in the northern community of Chesterfield Inlet in Nunavut, where her family lived briefly before moving to Ottawa. Donna earned her Bachelor of Sciences Honours at Queen's University, where she served as president of the Queen's Native Students' Association for two years and was a student representative on the Queen's University Aboriginal Council. Through her hard work and dedication, she is not only bridging the gap for Inuit accessing medical services, but she is leading the way for the next generation of Inuit youth to follow in her footsteps.



Katherine Whitecloud

Katherine Whitecloud, Mother and Grandmother, is Community leader and knowledge keeper from Wipazoka Wakpa Dakota Nation. Chosen at the age of 16 to represent her people, Katherine has been a spokesperson for her Nation for over 30 years. She has worked for the Community for over thirty

years in several roles, including Chief, Director of Education, CEO for the Assembly of First Nations, Director of the Assembly of Manitoba Chiefs, and Regional Chief of the Assembly of First Nations. Her work lies in ensuring the life and teachings articulated and envisioned by her forefathers is honoured and protected.



Professor Emmanuel Malabo Makasa

An Orthopedics and Trauma surgeon turned Global Health Diplomat, Dr. Makasa served as Deputy Director responsible for Emergency Health Services at the Ministry of Health, Zambia and as Secretary General of the Zambia Medical Association (ZMA) and the Surgical Society of Zambia (SSZ) before his current assignment as a Global Health Diplomat. He is a Fellow of the

College of Surgeons of East Central & Southern Africa (COSECSA) and serves on the boards of the Doctors Outreach care International (DOC-i) and Africa Directions (AD).

He is a honorary Lecturer at the University of Zambia, School of Medicine (UNZA-SoM), and a Trustee at the Lusaka Orthopaedics Research & Education Trust (LORET). Dr. Emmanuel M Makasa is the immediate past coordinator (2014) of Health Attachés' from the African Region at the UN in Geneva. He proposed, chaired and led the global intergovernmental negotiations that resulted in the adoption of the first ever resolution on surgery and anaesthesia at the World Health Organisation's 68th World Health Assembly.



Dr. Rosemary Mugwe

Rosemary is leading our advocacy with Governments, Regional Economic Communities, Intergovernmental organisations, Academic institutions and non-state actors to secure partnership and political commitment to strengthen paediatric surgical capacity interventions in the sub- Sahara region.

She is a lawyer with an advanced degree in development. While maintaining a busy surgical practice in Canada, he served as the Director of Trauma Services for the North West of Alberta from 2008 to 2016 and was the Chair of the Alberta Provincial Trauma Committee from 2014-16, which coordinated an integrated trauma system for 10 trauma hospitals in Alberta.

He attended medical school at the University of Toronto and completed his training as a general surgeon at the University of Calgary in 2000. He is a fellow of both the Royal College of Physicians and Surgeons of Canada and the American College of Surgeons, holding academic appointments at both the University of Calgary and the University of Alberta. Dr. Ibbotson also has a Master's of Science Degree from Queen's University and has multiple research publications.



Dr. Sherry M. Wren




Dr. Mumba Chalwe

Prof. Abebe has previously served as CEO of the Tikur Anbessa (Black Lion) Teaching and Specialized Hospital in Ethiopia and Dean of the School of Medicine of the Addis Ababa University. He is actively engaged in the Global Safe Surgery and Anesthesia Initiative and has served as a Senior Advisor to the Federal Ministry of Health, Ethiopia in the Saving Lives Through Safe Surgery (SaLTS) flagship initiative. He has authored more than 85 publication and book chapters.

Dr. Paola Fata



Dr Fata is Associate Professor of Surgery at McGill University whose clinical practice focuses on Trauma and Acute Care general surgery. Dr Fata completed medical school at McGill University, followed by General Surgery residency at the University of Manitoba where she also obtained a Master's of Science degree. She completed a trauma fellowship and was an attending surgeon at

Inova Fairfax Regional Trauma Center in Virginia, joining the faculty at McGill in 2005. She also completed the Teaching Scholar's Program at McGill.

Dr Fata is nationally recognized for her work in education and for her important leadership roles. For the past 4 years she has served as Assistant Dean, Resident Professional Affairs at the Faculty of Medicine. Prior to that, she was the General Surgery program director for a decade. As Assistant Dean she created multiple new policies and resources to improve resident well-being. Dr Fata has been recognized multiple times for teaching excellence at the Department and the Division levels, both for postgraduate and undergraduate teaching, and was named to the Faculty Honor List for Educational Excellence. She has twice served as an Osler fellow and received the Kathryn Rolph Award for contributing to the advancement of women in the Department of Surgery.

Dr Fata currently serves as President of the Canadian Association of General Surgeons (CAGS), having been asked to extend her term to a second year. During her tenure, she completed a comprehensive strategic planning exercise, stabilized the financial health of the society and significantly increased membership and attendance at the annual meeting. Prior to this role, she served on the CAGS board for over a decade and led multiple committees. In addition, Dr Fata has chaired and served on multiple committees at the Royal College, including co-chairing the specialty workforce collaborative and serving as vice-chair of the focused competency working group in trauma. Her research interests include the evaluation and improvement of learning environments and surgical workforce planning.



Dr. Gnanaraj Jesudian

Dr. Laëlle Mangurat

Laëlle Mangurat is a general surgeon with experience in working on facilities with limited resources. She is also teacher and clinical instructor at "Faculté de Médecine et de Pharmacie" of the State University in Port-au-Price, Haiti. As general surgeon she provides surgical care for trauma patients at all levels and stages at the trauma center leads by Doctors Without Borders at Tabarre/Haiti and also provides

emergency or elective surgical care, including trauma care, for patients at La Providence des Gonaives Hospital, a public second level center with around 150 beds. She shares a lot of passion for teaching, clinical research, global health, health systems strengthening, social change, gender equity and equity in access to healthcare. She is a site lead investigator for the PROTHA study and involved in study design, data collection tool adaptation and training.



Dr. Neema Kaseje

Dr Neema Kaseje: is a pediatric surgeon and public health specialist. She is an expert in building pediatric surgical care delivery with previous experience in Kenya, Haiti, Congo, CAR, and Liberia. In Haiti, she served as the only pediatric surgeon in the public sector and scaled up pediatric surgical care delivery in the region through the training of junior doctors. As a result, her team was able to double the number of children accessing life saving pediatric surgical care.

Similarly in Liberia, she was part of the first cohort of surgeons stationed to the first pediatric surgical program by a humanitarian organization such as Doctors Without Borders. Once again, she emphasized training and the setting of minimum standards and protocols as the foundation for improving access to pediatric surgical care in complex humanitarian settings. In Kenya, she has contributed to improved access to pediatric surgical care by leveraging technology and community health workers as powerful forces for the early detection and referral of children in need of life saving surgical care. In Turkana, Kenya, she is mobilizing women leaders to tackle the persistently elevated maternal mortality that is disproportionately affecting adolescent girls. These activities are key to the global conversations on health leadership as a mechanism for improved health, social cohesion, and inclusive economic development.

She is Founding Director of the Surgical Systems Research Group based in Kisumu, Kenya. She is committed to global health equity and improving access to surgical care as a pathway to rapidly achieving Sustainable Development Goals by 2030. She is actively involved in the Global Initiative for Children's Surgery. She is committed to youth in Africa and recently launched leadership training bootcamps for young girls aspiring to be leaders in health, technology, and science. There are plans to hold these leadership training bootcamps in Kakuma in 2020. She was named a Young Global Leader by the World Economic Forum in 2017, and was recently appointed as the focal point for the World Health Organization Programme in Emergency and Essential Surgical Care. She is currently leading a Welcome Trust funded integrated community and health systems based COVID -19 health intervention in Siaya, Kenya.
